ACADEMIC COUNCIL

Functions:

- Encourage participation in extracurricular and co-curricular activities to build well-rounded graduates.
- Facilitate collaborations with industry and academic institutions for research projects and knowledge sharing.
- Formulate and approve regulations related to admissions, examinations, grading, and attendance.
- Evaluate the effectiveness of academic programs through feedback from stakeholders.
- Provide necessary documentation and inputs for institutional accreditations and rankings.
