- Regularly inspect and ensure the proper functioning of all campus buildings, including classrooms, offices, laboratories, rest rooms, and recreational areas.
- Develop a maintenance schedule for all physical infrastructure to ensure cleanliness, repair, and upkeep
- Coordinate with utility providers to resolve any issues related to supply or infrastructure.
- Prepare and manage the budget for infrastructure and facilities maintenance, ensuring proper allocation of resources for repairs, upgrades, and development projects.
- Monitor expenditure and ensure that resources are used efficiently for maintaining campus facilities.
